FREQUENTLY ASKED QUESTIONS

- Is the Navajo Nation implementing a one grant concept? **NO**
 - One grant concept means all federal funds combined and allocated to Navajo government first, then distributed to schools.
 - Study explored the one grant concept as an options; however it was not feasible at this time.
- Is Department of Diné Education developing all of the plans for transfer of authority? **NO**
 - DoDE sought out expert consultants and stakeholders throughout the Navajo Nation to develop policy and procedures. DoDE continues to be committed to the transfer of BIE authority and to establish the foundation for building a strong Diné nation.



FAQ CONTINUED:

- Is the Department of Diné Education, Navajo Nation, or “Window Rock” taking over the BIE funded schools? **NO**
 - DoDE is a Navajo government agency responsible for establishing regulatory controls and carrying out compliance mandates
 - It is proposed that the Navajo Nation convert the 32 BIE operated schools to “Tribal Controlled Schools” as allowed by P.L. 100-297. The 32 schools will be transferred into a new education system called Diné Consolidated School System
- Will the schools receive their funding? **YES**
 - Schools will receive direct funding from Bureau of Indian Education (BIE) through the regional grantees. The money will not go through the Navajo Nation or DoDE (refer to Chart 1)
 - P.L. 100-297 is the law that governs grant schools funding. ISEP will determine funding levels per school.

FAQ CONTINUED:

- Will a school board still be under the BIE School Governance system when converted to Diné Consolidated School System? **NO**
 - Pursuant to P.L. 95-561, a school board serves in advisory capacity, and are only consulted on all school matters.
 - Once BIE schools are converted to tribally controlled schools within the DCSS, regional school boards will have full governance authority
- Will Diné Consolidated School System be grounded in student achievement and quality education? **YES**
 - Areas of School Reform:
 - Secure Highly effective Teachers and Principals
 - Establish agile school and learning environments
 - Promote self-determination in the education for Diné Nation
 - Develop partnerships with various entities to strengthen schools



FAQ CONTINUED:

- Will the Navajo Nation or DoDE be operating the schools? **NO**
 - Schools will be operated by the Diné Consolidated School System.
- Will the Navajo Nation or DoDE take indirect cost from the schools allocation? **NO**
 - The school will receive their full funding directly from the federal government as authorized by P.L. 100-297

The Navajos have a long history of dedication to education for their people. A few days before his death in 1893, the great chief, Hastiin Ch'il Haajiin (Manuelito) said, "*My grandchild, education is the ladder. Tell our people to take it.*" For the past five decades, the Navajos have allocated a relatively large proportion of their efforts and resources to improving educational opportunities for their tribal members.

DINÉ (NAVAJO) EDUCATION

- **1870** Congress appropriates \$100,000 to fund federal industrial schools for American Indians. The appropriation is the first monetary funding of Indian education in general.
 - **1878** Convinced of the necessity of education, Chief Manuelito, sent his sons and a nephew to Carlisle Indian School. However, they all died before they finished school; one son and a nephew died while home on a visit; the other son died at Carlisle.
 - **1887** Policy was adopted which physically forced some of the Navajo Children to attend off reservation schools, built for all Indians in such locations as Albuquerque, Phoenix and Fort Lewis
 - **1900-1910** Boarding schools opened up on the Navajo Reservation; the first six boarding schools were built in Tuba City (1902), Shiprock (1903), Tohatchi (1904), Crownpoint (1909), Leupp (1909) and Chinle (1910).
 - **1926** Secretary of Interior requested a thorough study of Indian conditions in the United States. The result is what is usually referred to as the Merriam Report.
 - **1966** With funding from Office of Economic Opportunity (OEO) and BIA, the Rough Rock Demonstration School began operation, as the first Indian-controlled school in the country.

DINÉ (NAVAJO) EDUCATION (CONT.)

- **1970** Nixon's "Special Message on Indian Affairs." President Richard M. Nixon delivered a speech to Congress which denounced past federal policies, pronounced the end of termination, and called for a new era of self-determination for Indian Peoples.
 - **1975** Indian Self-Determination and Education Assistance Act (P.L. 93-638). This law recognized the obligation of the US to provide for maximum participation by American Indians in federal services to and programs for Indian communities, established a goal to provide education and services permitting Indian children to achieve, and declared a commitment to maintain the federal government's trust relationship and responsibility to individual Indians and tribes.
 - **1988** P.L. 100-297 "Trially Controlled Schools Act" provided tribal governments or tribal organizations the ability to convert existing BIE-operated (federal) schools into P.L. 100-297 grant schools who total authority over schools. Under P.L. 100-297, funding goes directly to the schools.
 - **2005** Navajo Nation Council passed the Navajo Sovereignty & Education Act of 2005 that established a Navajo Nation Board of Education and Department of Diné Education as the administrative and regulatory agency to oversee operations of all schools under its jurisdiction. (Resolution CJY-37-05)

 - Revitalize Navajo Language and Culture
- To develop the Diné Consolidated School System (DCSS)
 - Establish excellence in education for all students
 - Revitalize the Navajo Language and Culture Curriculum
 - Establish operation effectiveness in federally funded schools

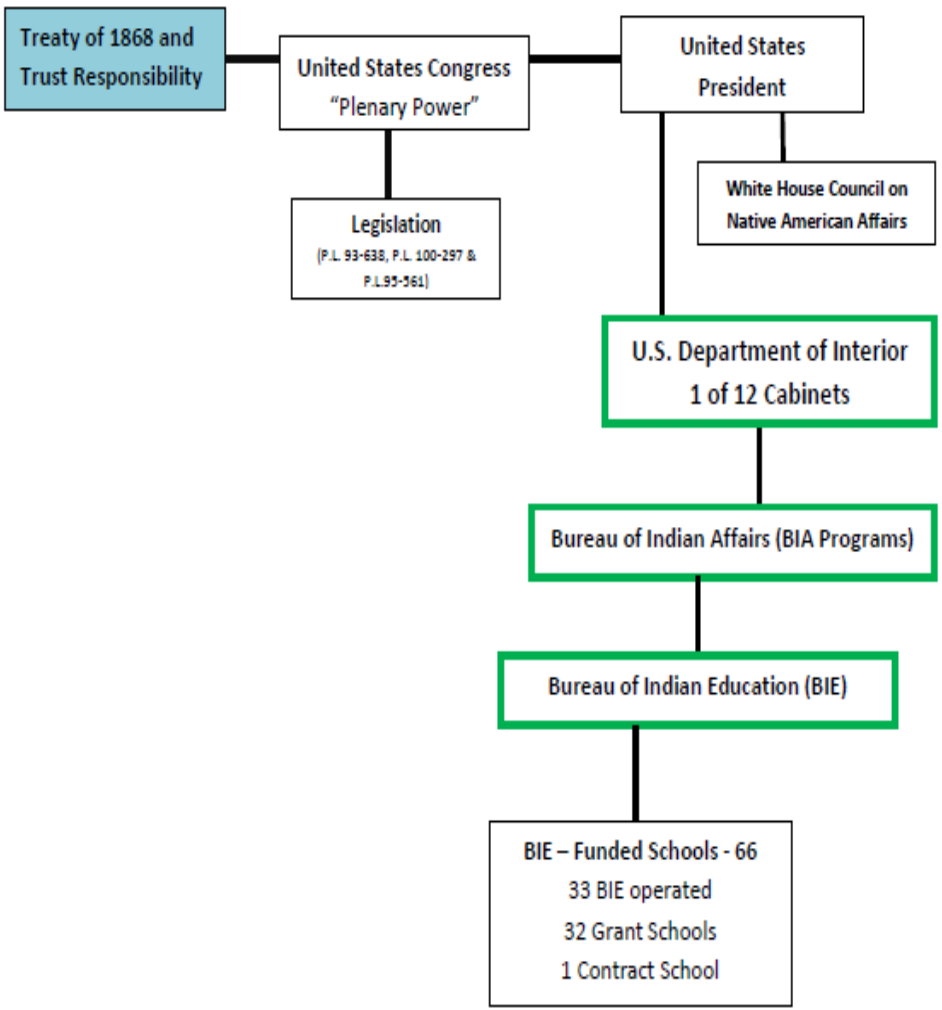

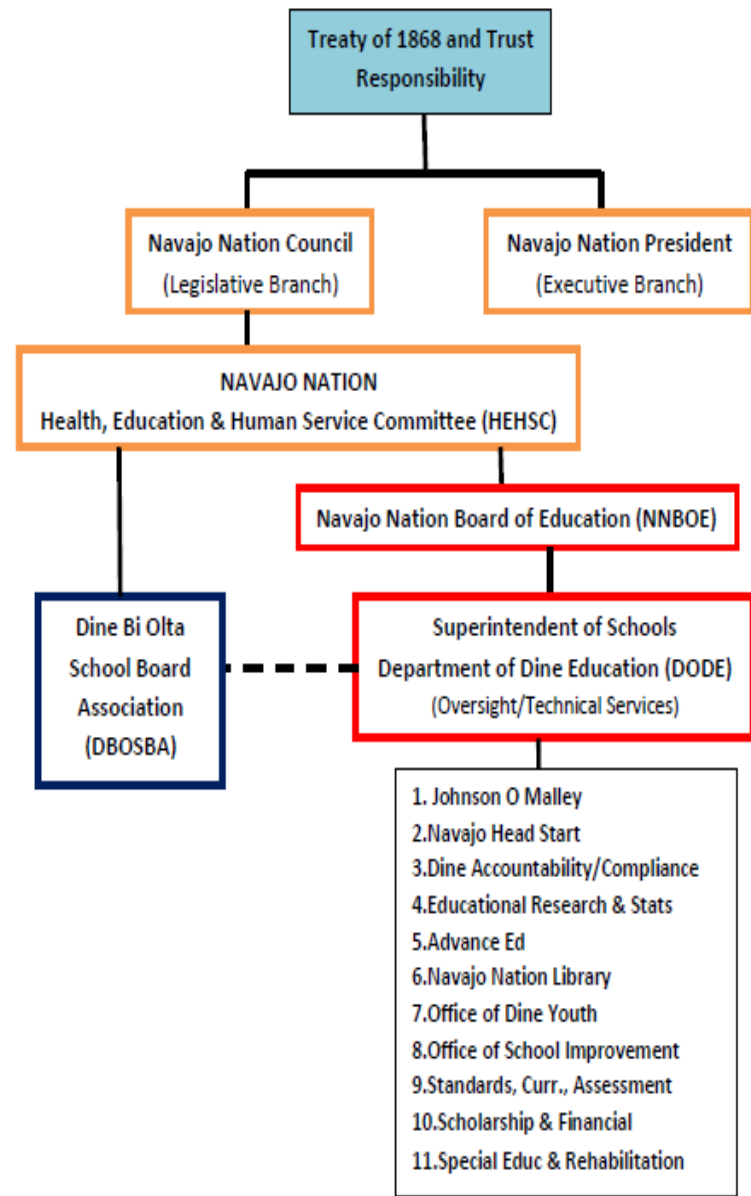

PROPOSED BIE "TRANSFER OF AUTHORITY" AND RESOURCES

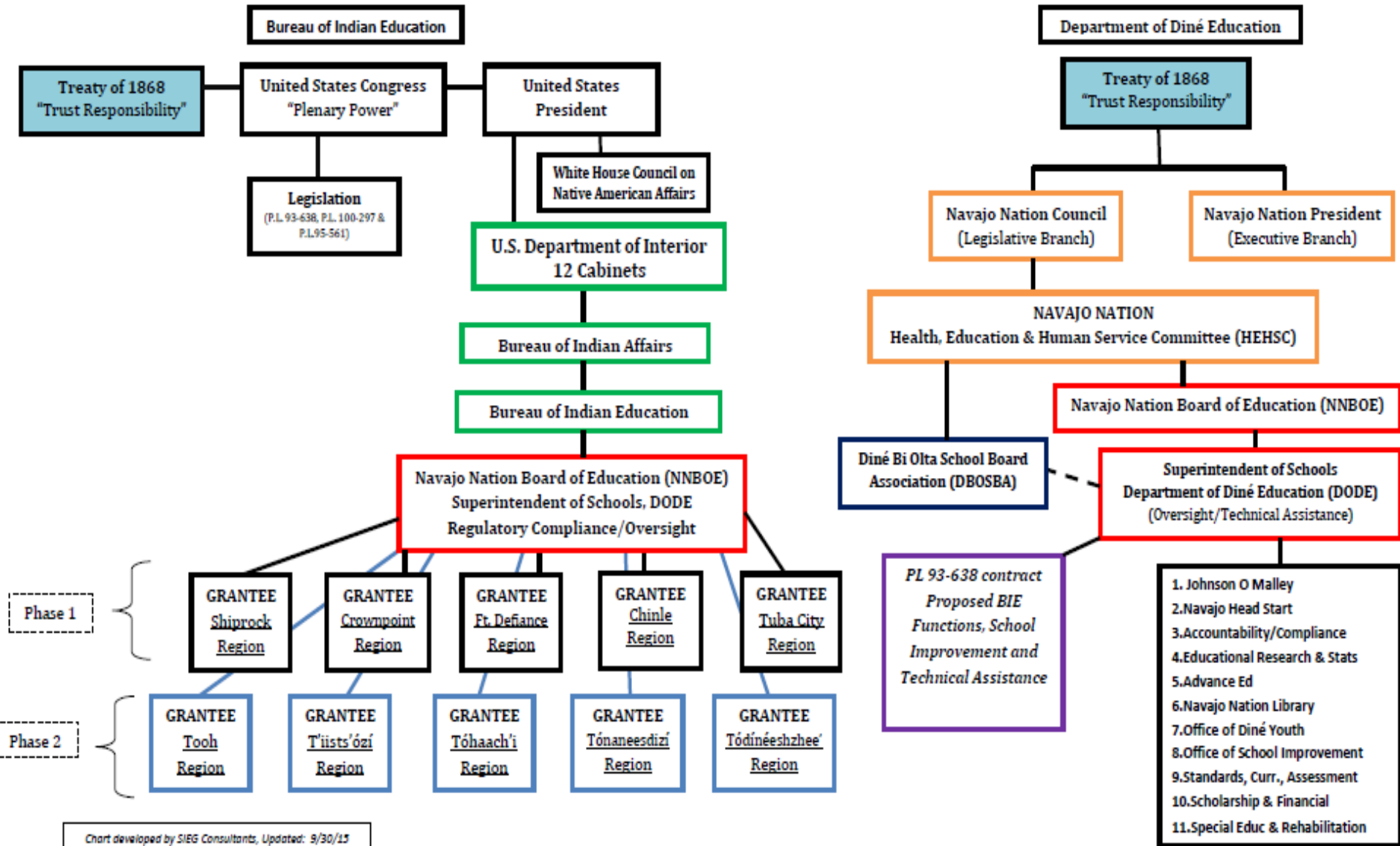
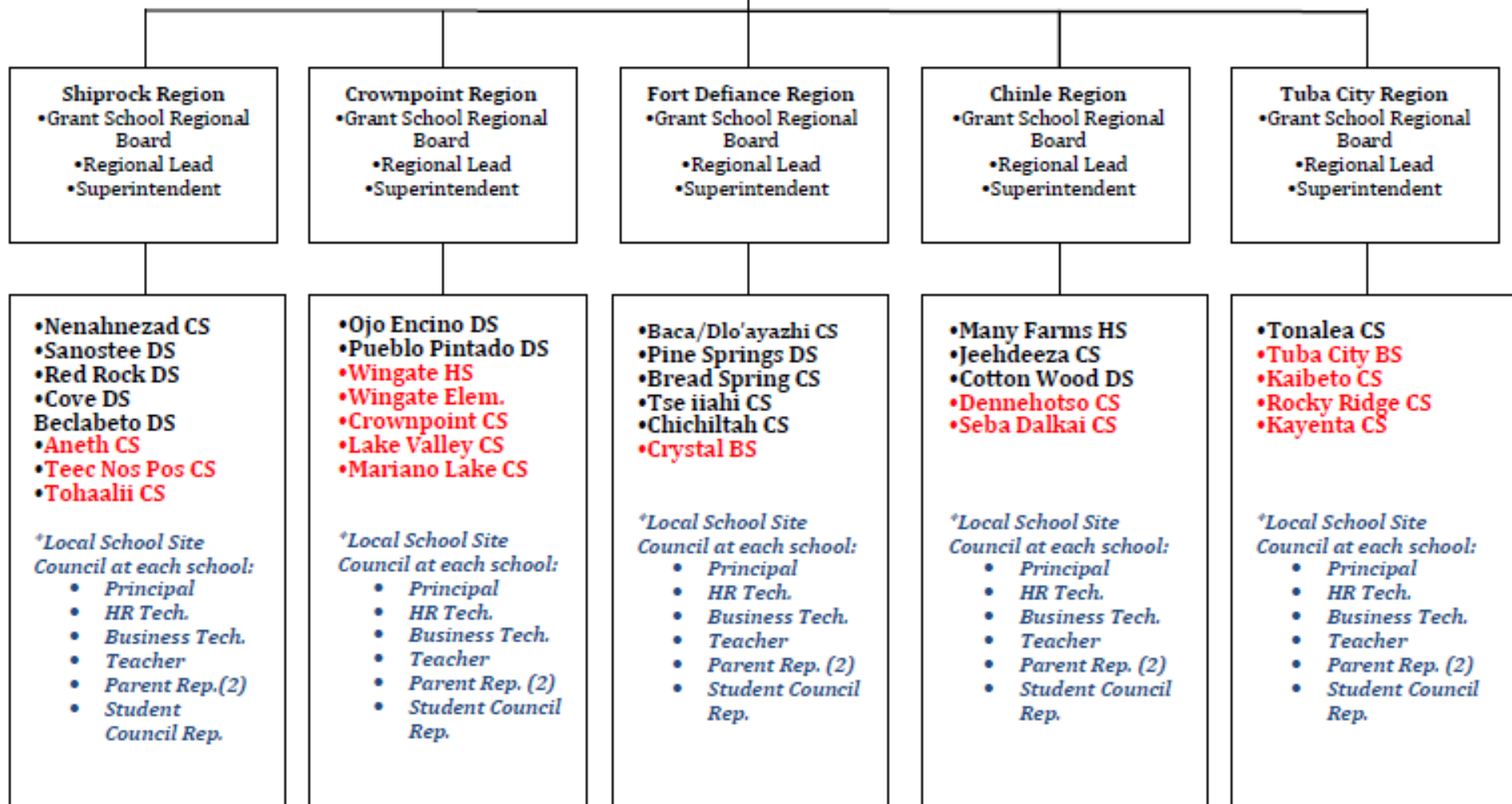

Diné Consolidated School System

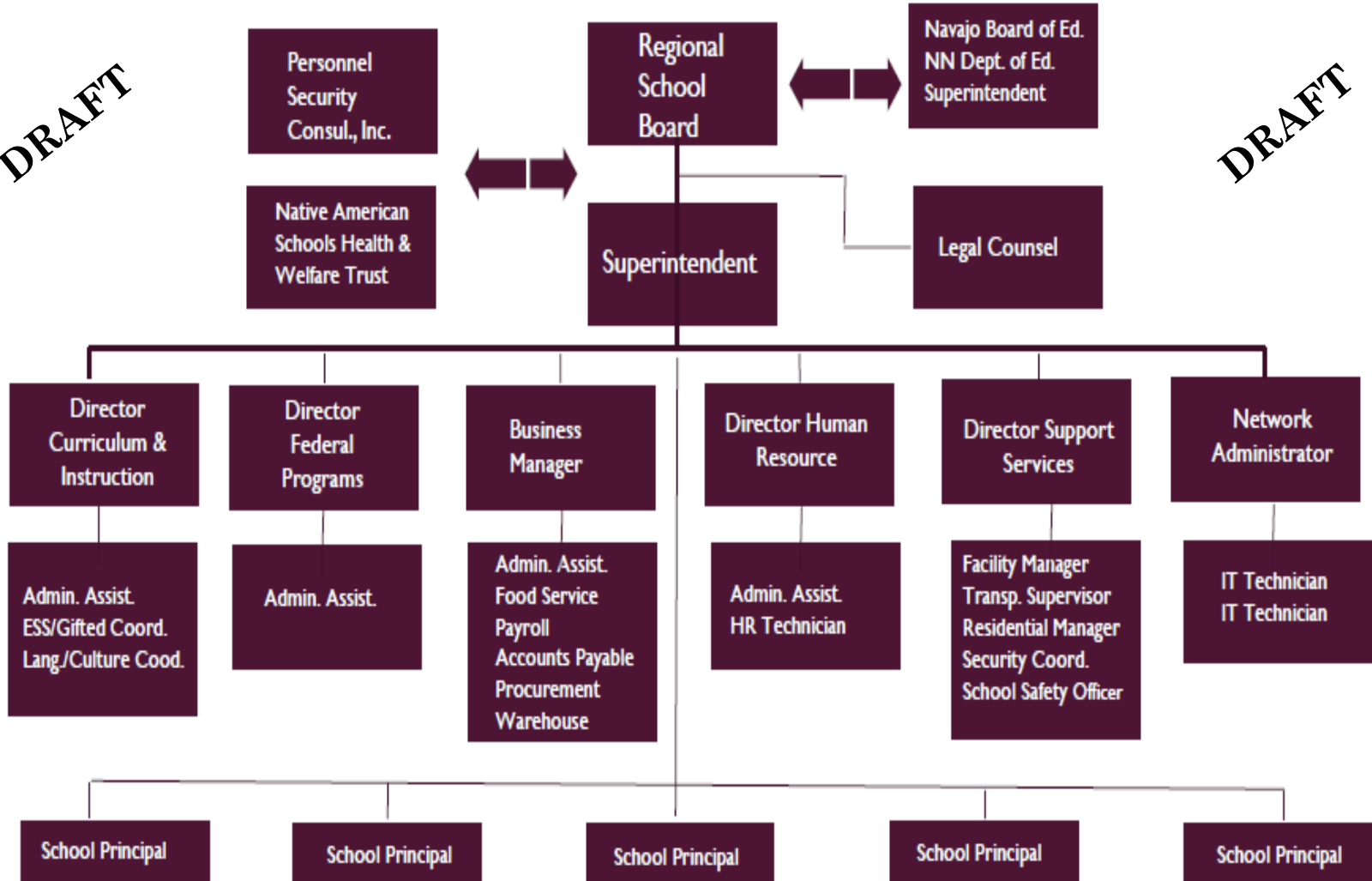
